WHEREAS the settler desire to establish a Permanent Charitable Trust for advancement of education, providing medical relief and rendering aid to the poor and the distressed people, to create awareness & implementing environment & pollution related work etc. and for other charitable objects as hereafter mentioned;

AND WHEREAS for the said purpose the said settler have contributed and set apart Rs. 1,000/- (Rupees One Thousand) and is now desirous of settling the said total sum of Rs. 1000/- upon the trusts and objects and subject to the powers and provisions hereinafter declared and contained;

AND WHEREAS at the request of the settler, **KETKI CHANDRAMAULI JOSHI**, parties of the other part as mentioned above , have agreed to become the first Trustees under these presents and as such Trustees have joined in and are executing these presents;

AND WHEREAS the Settler have paid and handed over to the Trustees the said sum of Rs. 1,000/- on 14th June, 2017 (the receipt whereof the trustees do and each of them do hereby acknowledge).

NOW THIS INDENTURE WITNESSETH that in consideration of the premises and for diverse other good causes and considerations, the Settlor do hereby assign and transfer unto the Trustees the said total sum of Rs. 1,000/- (Rupees One Thousand) and the accumulations thereof and the accretions

thereto and the investment thereof for the time being representing the same unto the Trustees to have and hold the same unto the trust declarations and conditions hereafter expressed and declared.

- 1) The Trustees do and each of them hereby agree and declare that they the Trustees shall and will hold and stand possessed of the said total sum of Rs. 1,000/- (Rupees One Thousand only) made over to them as aforesaid and of all future donations and further sums or properties and gifts as may from time to time be donated received or acquired in this Trust by the Trustees and of all the income interest, dividends and rents thereof with accumulations thereof and the additions and accretions thereto and the Investments for the time being representing the same upon the trusts and with and subject to the objects, powers and provisions hereinafter declared of and concerning the same.
- 2) This Trust shall be designated and known as **"PRAYAG PARIVESH SANSTHAN"**. The office of the trust will be situated at **46, SUKSHINE COMPLEX, SUNRISE PARK MAIN ROAD, OPP.: GALAXY BZAAR, DRIVE-IN, AHMEDABAD-380054, (GUJARAT)**. The Trust can open branches at any place in India for carrying out the activities for fulfilling the objects of the trust. The area of operation the trust will be limited to whole of India only.
- 3) The Trustees shall stand and be possessed of the said sum of Rs. 1,000/- and all future donations, gifts and accretions and additions thereto and also income, rent, interest, dividends and profits thereof and the investments representing the same (all of which hereafter also collectively referred to as "The Trust Fund") upon the following Trusts that is to say :-

- a) In the first place out of the income, interest, dividends and/or rents to reimburse themselves and to pay and discharge all costs, charges and expenses incurred in or about the management and administration of the Trust under these presents and if the properties and assets belonging to the Trust;
- b) To apply and utilize the residue of such income, dividends, interest, dividends and/or rent and profits of the Trust funds and/or also the whole or any part of the corpus of the Trust Fund and properties for the time being and future donations for all or any one or more of the following objects and purposes for the benefit of all persons without any distinction of color, caste, creed, community, region or religion to the intent that the same shall relate to anything done or to be done within India and in such proportions and in such manner in all respects as the Trustees may in their absolute discretions think proper that is to say :-

OBJECTS OF THE TRUST

- i) Generally for advancement of education, relief to the poor and distressed persons and for giving or providing medical aid and treatment.
- ii) To provide monetary and other assistance and to give equipments, instruments, book, fees or Scholarships or loan Scholarships (with and without interest) to enable deserving students to prosecute studies in educational institutions imparting general, professional, vocational, commercial, cultural and/or technical education.

- iii) To assist, establish, promote, maintain and/or give donations and monetary or other help to schools or colleges or Balmandirs or educational institutions, gymnasiums, Hostels, or Boarding for Students taking education.
- iv) To assist, establish, promote, maintain and/or give donations to dispensaries and hospitals, sanatoriums and other institutions giving medical relief and aid or for promoting health.
- v) To assist, establish, promote, maintain and/ or give donation to clubs, training institutes and other institutions for promotion of sports and games including yoga, gymnastics and establishment and maintenance of various facilities required for the same.
- vi) To give either directly or through any institution, organization or Trust relief and/or assistance to persons in distress caused by natural calamities, famine, fire, tempest, floods, earthquake, poverty, physical infirmities, illness and other misfortunes.
- vii) To provide monetary and other assistance in cash or kind for medical or similar aid in sickness or infirmity to the people and/or give donations to institutional organizations or trusts established for giving relief from any form of illness, poverty or distress and for maintaining humanitarian and benevolent Societies, Organizations or Institutions etc.

viii) To give and make donations and gifts with or without conditions to schools, colleges, hospitals, dispensaries, Nursing house or institutions or Associations or those mentioned herein.

ix) To declare and award prizes in cash or kind, trophies and/or scholarship competitive or otherwise in encouragement of Education, Sports or Gymnastics etc.

x) To provide monetary and other assistance for carrying out research in Science, Sociology, Humanities etc.

xi) To assist, establish, promote, maintain and/or give donations to cattle campus, Panjrapole, Water huts, Dharamshala, Bhojanshala, Welfare centre, Old age home, Orphanage homes, Research Centers, Yoga Centers etc.

xii) To carry out the activities & implement the programmes for saving of environment, pollution control, protection of natural resources, afforestation etc & to create awareness & educate people for the same.

xiii) To take over the management of or amalgamate or merge with any Trust, Society or other Organizations or Institutions having objects similar those mentioned herein.

xiv) For the advancement of any object of general public, welfare and utility as the law may regard as a public charitable object and for one or more of such purposes to the exclusion of other or others as the Trustees may think fit.

xv) The objects of the trust are for the public at large without any distinction of colour, caste, creed, region, religion or language etc.

xvi) The activities for fulfillment of the objects are to be carried out within India only.

It is intended and directed that if at any time hereafter it is held that any of the objects and purpose to which funds or said income or any part thereof is directed to be applied or expended is not a public charitable purpose or object for the purpose of tax benefits under the Income-tax Act and other Taxation Laws for the time being in force, then and in that case the Trustees shall apply and expend the said Trust Funds and the income or corpus thereof for and towards the execution and carrying out of only such of the said objects and purposes which may be considered public charitable objects or purposes according to such Laws.

4) Any moneys forming part of the trust funds for the time being and from time to time received by the trust and not immediately required for carrying out the objects of the trust may be invested in the names of the Trust through Trustees by passing appropriate resolutions in the names of any two or more of them in any of the following investments i.e.

a) In securities, Government loans, Bonds or Debentures, Units of the Unit Trust of India, Mutual Funds, FDR or such other Securities or investment as may for the time being be authorized by and/or under the Indian Trust Act 1882 or the Bombay Public Trust Act 1950 and Income Tax Act, 1961 or any statutory

modification thereof or as may be authorized by and under the laws for the time being for investment of Trust Funds;

- (b) In or upon the first mortgage and charge by way of mortgage or contributory mortgage of immovable properties including the lease – hold properties for a term of years situated in India ;
- (c) In fixed or other kind of deposits or current or savings Account with post officers or any scheduled bank, Co-Operative Banks or state controlled Banks ;
- (d) In the purchase of immovable property or properties, lands and buildings of any tenure;
- (e) In stocks, Debentures, Mutual Funds, stock or shares and whether equity preference or otherwise in Joint Stock Companies.

As regards investments mentioned in sub-clauses (d) and (e) the Trustees shall obtain such sanctions as may be necessary under the provisions of law for the time being in force.

And the trustees shall have the power to sell or dispose of such securities or any part thereof and to invest the same in any of the securities hereunder authorized and from time to time in their discretion to vary such investments.

- 5) In the event of the Trust properties or any part thereof comprising of or being invested in the purchase of immovable property or properties, the Trustees shall have power from time to time to sell all or any of the immovable properties forming part of the trust premises either by public auction or by private contact upon such terms and conditions as the trustees may think proper and to buy in at such sale by auction and rescind or vary any contract and to enter into any new contract without being responsible for loss or to exchange the same or any of them respectively and also to let out the same or any part thereof respectively for any term of years on such terms as the Trustees may think proper.

- 6) a. The number of Trustees shall not be less than three and not more than eighteen out of which as far as practicable at least one trustees shall be appointed from the descendants of **KETKI CHANDRAMAULI JOSHI** and / or from the members of families of such descendants. The trustees are life time trustees.
- b. Any trustee wishes to resign from his post, has to give notice of one month in advance. Before completion of one month, the other Trustees have to inform about acceptance or rejection of the resignation to him, & the remaining Trustees shall appoint new deserving Trustee by simple majority.
- c. Any one of Trustees or Trustees dies, become bankrupt , commits crime or proved by court to be involved in such work, become incompetent physically or mentally, works against the interest of the Trust, Uses Trust property for his own purpose without permission, keeps huge cash amount of trust with him for long time without any reason or permission, shall be removed as a Trustee, by passing a resolution & appoint any deserving person with simple majority.
- 7) For the proper management of the trust and of the Trust properties and funds , the Trustees may by a majority of the votes elected from amongst themselves one Managing Trustee who shall be entitled to preside at all meetings of the Trustees. In the absence of such Managing Trustee at any meeting, the Trustees then present shall appoint a chairman for such meeting. At Present Managing trustee will be **KETKI CHANDRAMAULI JOSHI** and future Managing Trustee shall always be direct descendants of **KETKI CHANDRAMAULI JOSHI**. Approval of Managing Trustee is compulsory in all decisions having long lasting effect.

- 8) There shall be at least two Trustees be present in a meeting to form quorum. No business shall be transacted at any meeting of trustees unless there shall be a quorum but if a meeting is adjourned for a want of quorum, then at such adjourned meeting, the quorum shall not be necessary. No business shall be transacted at any such adjourned meeting other than the business on the agenda of the last adjourned meeting..
- 9) All questions at meetings of the Trustees shall be decided by a majority of votes of the Trustee present in person at the meetings. In the event of a tie, the Managing Trustee / Chairman shall have a second or casting vote.
- 10) Meetings of the Trustees whenever necessary shall be held at such time and place as the Trustees may decide. The Managing Trustee may at any time and shall at the request of any two Trustee convene a meeting for any matter of urgency or importance. The Agenda of the meeting will be intimated to the trustees either by message, post, Fax , E-mail , Phone or any other Electronic Gadgets.
- 11) The Trustees may dispose of any question or pass any resolution by a circular duly signed by all the Trustees in India provided that all work disposed off by any such circular should be reported at the next meeting of the Trustees and duly recorded in the Minutes book.

In case of difference of opinion on a circular such question or resolution shall be dealt with at the next meeting of the Trustee.

- 12) The Managing Trustee or, if a secretary is appointed, such secretary shall keep or cause to be kept a Minute Book containing clear reports of the proceedings at the meetings of the Trustees. The Minutes shall be signed by the Chairman who presided over and in case he is not available to sign the minutes then by the Chairman of the next succeeding meeting and shall be prima facie evidence of such proceedings.
- 13) The Trustees shall be entitled to keep the accounts in Gujarati or English. The Trustees may employ an Accountant or Clerk for maintaining accounts and for management and administration of the Trust Properties. The Trustees shall keep proper books of account and records wherein entries shall be made in the ordinary course of business of all moneys received and paid in cash or otherwise on any account whatsoever. The said books of accounts etc. shall ordinarily be kept at the office of the Trust and shall be open to inspection by the Trustees.
- 14) The Trustees shall be entitled to acquire or to hire on rent a place for office of the Trust for holding meetings and transacting business of the Trust.
- 15) The Management and control of the Trust premises and affairs of the Trust aforesaid shall be vested in the Trustees and shall inter alia have the following powers that is to say :-
- a) To make and frame from time to time such bye-laws rules and regulations of the management and administration of the Trust and its properties and the institutions, if any, run by the Trust as the Trustees shall think necessary and proper and to alter add to repeal, amend or rescind, such bye – laws rules and regulations as the Trustees shall at their discretion think necessary and proper.

- b) At any time to invite and receive with or without any condition as the Trustees may deem proper from any person or persons whosoever whether by way of donation or other subscription dues legacy or otherwise and to hold the same upon the Trusts and powers herein declared and contained. PROVIDED HOWEVER that the Trustees shall not accept any donations offered and earmarked for the benefit of persons belonging only to any particular community or religious group Provided Further that the Trustees shall be at liberty at any time to refuse any donation or contribution without giving any reason for such refusal.
- c) To appoint and constitute whenever necessary a Managing Committee or Committees for the management and administration of day-to-day affairs of the Trust or any institution or institutions which it may run and manage and to delegate to such Managing Committee or Committees such powers as the Trustees might deem proper for the purpose of day-to-day administration of the said institution. The Trustees shall be entitled to appoint any person or persons, as a member or member of any such Managing Committee or Committees even though such person or persons may not be a Trustee or Trustees under these presents. The Trustees shall have power to remove any such person or persons to dissolve the Managing or Other Committee without being bound to give any reason for the same.
- d) To appoint a paid Secretary independently or jointly with an Honorary Secretary.
- e) To appoint and remove bill collectors, watchman, accountants, paid Secretary or any personnel required for the administration of the Trust property.

- f) To borrow money for the purpose of carrying out the objects of the trust with or without security on such terms and conditions as the Trustees may think proper.
- g) The Trustees shall be entitled to open Bank Account in the name of the Trust or with any bank including co-operative bank and maintain a Banking Account or Accounts which may be operated by any one or more of them as decided by the trustees at such Bank or Banks as the Trustees may from time to time decide. The Trustees may pay or cause to be paid any money forming a part of the trust fund or the income thereof to the credit of any such account or accounts and either by way of Fixed Deposit, current or Savings Account.
- h) To take over the management of or amalgamate or merge with any Trust, Society or other organizations or Institutions having objects similar to those mentioned in clause 3 above and established for the benefit of all persons without any distinction of colour, caste, creed, community, region or religion.
- i) The trustees shall be able and eligible to raise funds for advancement of any of the objects of the trust through various means including receiving donation, grants, financial help of any other kind from Central Government, any State Government, any institutional bodies and other charitable trust having similar objects and any other person including foreign donations from individuals as well as institutions/trust etc.
- 16) The Trustees shall be at liberty at any time at their uncontrolled discretion instead of acting personally to employ and pay any agent (including any Bank) to transact any business or to do any act whether in relation to the Trusts or these presents

- 17) It is hereby agreed and declared that the receipt or receipts of the Managing Trustee alone or of any two of the Trustees for moneys paid in respect of income, dividend, interest, rent etc. of any moveable or immoveable property or for any stocks, funds, shares and securities, transferred or vested in the Trustees or in respect of any money which may otherwise become payable to the Trustees by virtue of these presents or in the execution of any of the trusts hereof shall effectually discharge the person or persons paying or transferring the same therefrom without being bound or liable to see to the application thereof.
- 18) It is hereby further agreed and declared that the Trustees shall be respectively chargeable only for such moneys stocks, funds, shares and securities as they shall respectively actually receive notwithstanding their respectively signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts neglects and defaults and not for those of each other nor for any banker broker auctioneer agent or other person with whom or into whose hands any trust moneys or securities may be deposited nor for the insufficiency or deficiency of any stocks funds shares or securities nor for any other loss unless the same shall happen through his/her or their own willful default respectively.

- 19) It is hereby also agreed and declared that the Trustees shall be at liberty to deposit all securities or the investments for the time being representing the trust fund with any Bank including co-operative bank as defined in the Reserve Bank of India Act 1934 or State Controlled Bank and in any other mode of investment as prescribed by Bombay Public Act & Income tax Act for safe custody and for collection of the interest dividends and income of the said securities and to open Current or Savings Account in the name of the Trust their names with the said Bank and to continue that account until such time as the Trustees shall deem fit and the Trustees shall be at liberty to pay out of the income of the Trust premises any reasonable fee or commission charged by the Bank for undertaking such obligation.

- 22) The Trustees of these presents shall be entitled to reimburse themselves and pay and discharge out of the Trust Fund all expenses incurred in or about the execution of these presents and of the Trusts and powers of these presents.

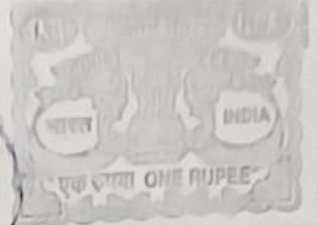
